One letter of recommendation is required for Affiliate Membership. This letter should accompany your application and must be written by a Life, Full, Provisional, or Corresponding CAC member. Your application form, check, photo, and letter of recommendation must be sent from that CAC reference.

Concerning journal subscriptions (Journal of Forensic Sciences and Science & Justice), the treasurer will contact you through the dues notice sent out in September for November payment. (If you become a member in October, you will not be able to order journals through the CAC until the following dues cycle)

When the paperwork is complete, it is presented to the CAC Board of Directors for approval; if approved you will become an affiliate member at the end of either the Spring (May) or Fall (October) seminar, whichever comes first. Applications must be submitted **2 weeks** prior to the next seminar in order to be considered for submission to the general membership for voting. Applications received after the deadline will not be processed until the following seminar.
